All POPULAR Suppliers are expected to abide to PSAP, as follows. 大众要求所有大众供应商须遵守以下的大众供应商反贪污政策。

### PSAP

### 大众供应商反贪污政策

Suppliers should not allow, accept or engage in bribery (whether in cash or in kind), collusion, deception, embezzlement, entertainment, extortion, favouritism, fraud, hospitality, kickbacks or other forms of corruption in dealings with the employees of POPULAR, whether in cash or in kind.

供应商在与大众的雇员进行交易时,不允许,接受或从事贿赂(不论是现金还是类似的财物),共谋,欺骗,侵吞公款,公款招待,敲诈勒索,偏袒,欺骗,招待,给予回扣和其他等方式的腐败行为,无论是现金方式还是类似的给予财物方式。

Suppliers should comply with all applicable local, national and international laws, including where applicable, the Corruption of Foreign Public Officials Act (in Canada), Prevention of Bribery Ordinance (in Hong Kong), Malaysian Anti-Corruption Commission Act 2009, Prevention of Corruption Act (in Singapore), Anti-Corruption Statute (in Taiwan), US Foreign Corrupt Practices Act, the Bribery Act (in the United Kingdom), and Principle Ten (10) of the United Nations Global Compact which states that "businesses should work against corruption in all its forms, including extortion and bribery".
